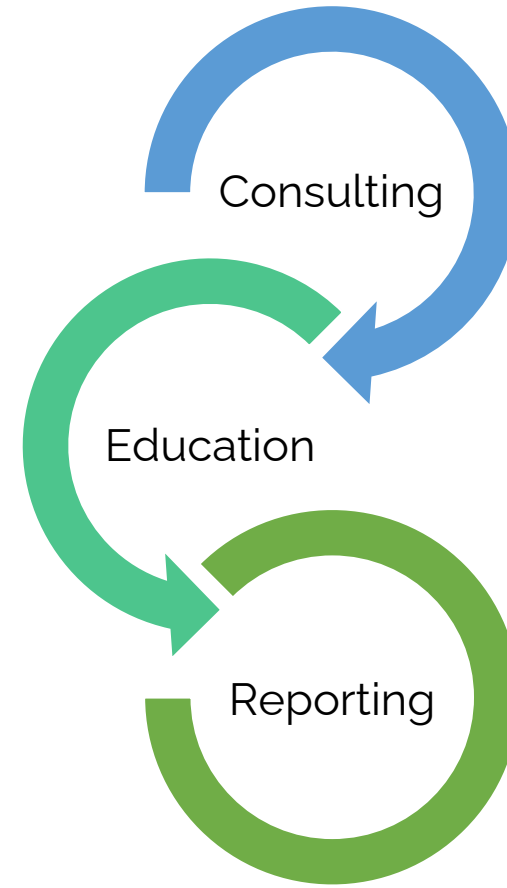

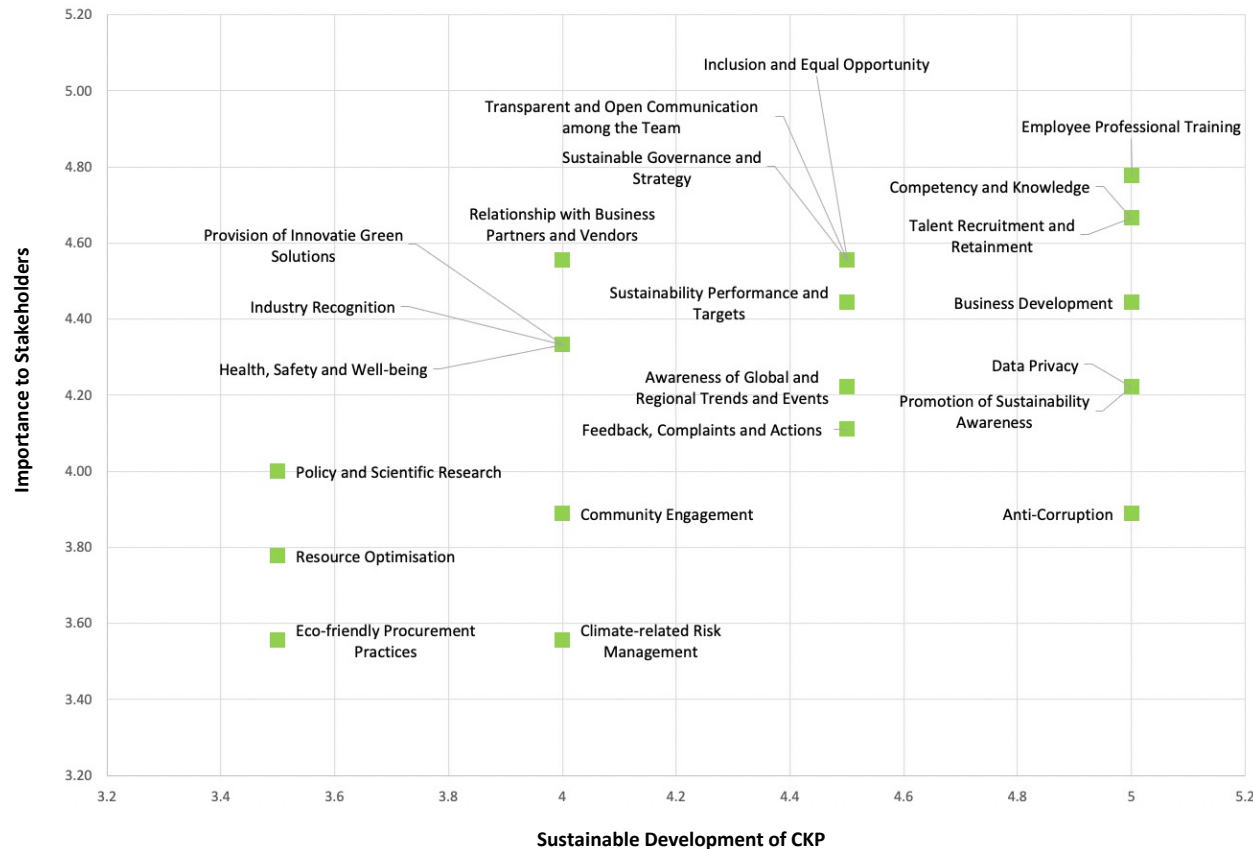

Vegan Baking Workshop - TEDxTinHau Countdown

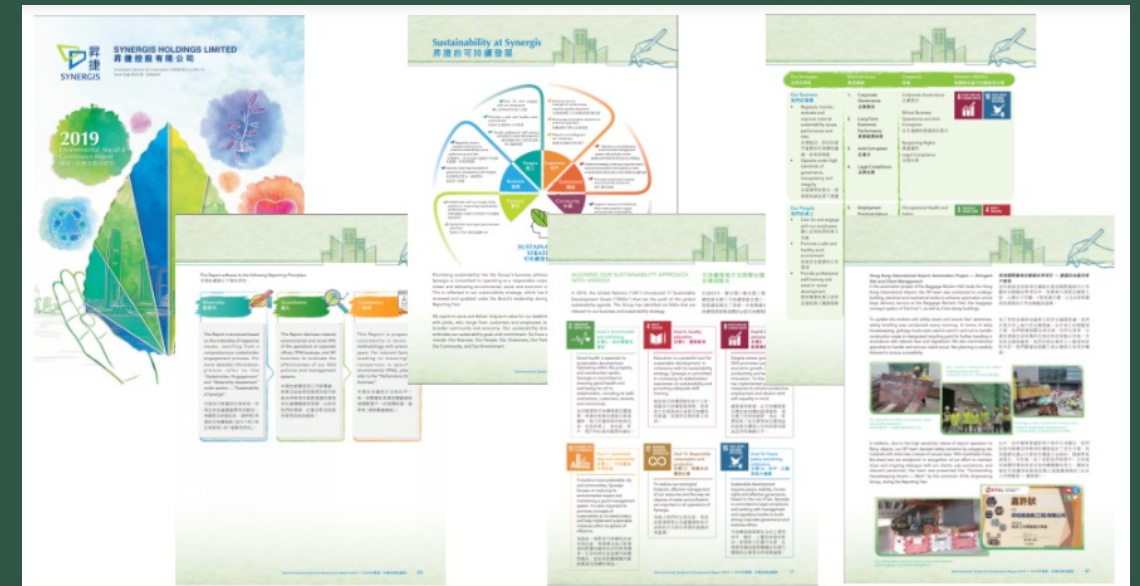

Synergis Holdings Limited

Many companies have defined their sustainability commitments, goals and strategies, but putting words into action is often challenging. Through adopting a holistic perspective, CKP transformed Synergis Holdings Limited's ("Synergis") approach to ESG management and guided them in their journey to recognise the environmental and social impacts in their operations. In the past four years, we conducted a comprehensive stakeholder engagement, identified material ESG issues, built a KPI database, formulated their first sustainability strategy, and assisted in forming an ESG committee. In the annual sustainability reporting process, we helped Synergis identify sustainability-related risks and aligned their priorities with the SDGs. Since engaging with CKP, Synergis has seen progress in reducing their environmental impacts and have been recognised externally for their social achievements.

SBTi Feasibility Study

As part of our global efforts to meet the Paris Agreement, we assisted companies in making their transition to a low-carbon economy. The CKP team helped perform an initial assessment for Hongkong Land Limited on the feasibility and potential challenges of committing to and setting a Science-based Targets Initiative (SBTi) target. We recommended to develop a carbon reduction plan that assesses the entirety of the operations in line with the SBTi criteria. This helped Hongkong Land assess their opportunities and next steps to reach their goal.

MDF Recyclability

For the first time, we conducted a sustainable material research and consultancy service for L'Alliance and Yves Saint Laurent SAS's Chinese New Year pop-up store. Temporary structures can generally be quite wasteful, hence we provided customised recommendations on eco-friendly material alternatives to reduce the overall environmental footprint.

Informational Education Programs

We are passionate about providing our clients and community with the knowledge, skills, and actions required to implement changes within their organisation. Over the years, we have partnered with various listed and private companies in offering training and education programs that are customised to their needs and requirements. We want to make addressing environmental and social issues easier to comprehend. It is not simply about reducing consumption, but rather reviewing internal and external processes that may affect various aspect of operations. Through education, we strive to empower people to change the way they think and work towards a sustainable future.

Seminar on New ESG Reporting Requirements

On December 2019, the Stock Exchange of Hong Kong announced a series of updated ESG reporting requirements including the disclosure Board's oversight in ESG issues, ESG strategy, materiality assessment, KPI data and targets, climate change mitigation measures and sustainable procurement practices. To help our clients prepare for the requirements taking effect in 2020, we delivered a seminar speaking about the major reporting changes, practical steps, and recommendations that respond to the disclosures.



English School Foundation

With our third year running, CKP conducted our signature training program to the English Schools Foundation ("ESF"). A group of ESF students were trained to create an organisation-wide sustainability strategy and taught to implement it at each of their 22 respective schools. In our training program we educated students basic sustainability concepts, real life consulting processes, stakeholder engagement, public speaking and debating skills, presentation skills and more. The program was well received by all stakeholders, including students, teachers and staff, parents, and the community. At the end of the program students were equipped with the essential knowledge to embed sustainability in their schools strategically and practically.



Respecting Our Environment

As a sustainability consultancy it is important that we walk the talk. Our activities at the office are governed by our Environmental Policy where we strive to be mindful about the use of resource, energy consumption and procurement of goods and services. Due to the nature of our services, we produce minimal office waste, while hazardous waste production is immaterial to our operations. - Encouraged 2-sided printing/photocopying
- Used electronic mail for communication and online electronic filing
- Bring reusable cups
- Recycled waste where appropriate (e.g. paper/carton boxes, aluminium cans, plastic bottles and laser print cartridges)
- Regularly updated monitoring logs to track use of resources

Energy Conservation



- Switched off unnecessary lights
- Installed and activated energy saving software in computers
- Switched off computers, printers, photocopiers, lighting and air-conditioning when they are not in use
- During summer time, maintained an average indoor temperature between 24-26°C to save energy;
- During winter time, encouraged opening the window for ventilation;
- All electrical appliance such as lamps, computers, water dispenser, fridges and fans are regularly maintained

Water Conservation



- Checked automatic sensors on faucets, toilets, and urinals to ensure they are operating properly
- Analysed water consumption data periodically to review water conservation measure for continuous improvement
- Carried out regular leakage tests

Other Environmental Practice



- Avoided use of hazardous substances or materials wherever possible
- Avoided use of toxic substance or materials that may create specific waste treatment/disposal problems
- Used environmentally friendly modes of transport to and from the Company
